#### 1. Introduction

This cookie policy describes how we at Nordisk Bergteknik AB, corporate identity number 559059-2506 ("Nordisk Bergteknik", "we", "our" and "us"), with the address Östra Hamngatan 52, 411 08 Gothenburg, use "cookies" on our website.

#### 2. Our use of cookies

A cookie is a text file that is saved on your browser or device. We use both permanent cookies (which are stored on your device for a certain period of time) and session cookies (which disappear from your device when you close your browser). The cookies we use can also be first-party cookies (placed on your device by us) or third-party cookies (placed on your device by third parties).

We use cookies to analyze visitor traffic and to monitor the frequency of visits to our website, as well as to improve the functionality of our website, e.g., to customize your user experience and remember information you provided to us when you visited our site.

Below is a summary of our use of cookies:

Type of cookie used	Purpose of use	Storage time
INGRESS COOKIE  Nginx, session cookie, third- party cookie, functional cookie.	Load balancing for the Nginx server environment	Deleted from your device when you close the browser
cookie_notice_accepted Cookie Notice, permanent cookie, third-party cookie, functional cookie.	Creates a cookie that senses the visitor's choice when the visitor via the cookie pop-up banner agrees that cookies may be used by the website.	Up to one (1) month.
pll_language Polylang, permanent cookie, third-party cookie, functional cookie.	Used by language management, the program Polylang. Knows which language the user chooses on the site.	Up to one (1) year.
_ga Google Analytics, permanent cookie, third-party cookie, performance cookie.	This cookie is installed by Google Analytics and is used to anonymously distinguish one unique visitor from another.	Up to two (2) years
_gid	This cookie is installed by Google Analytics.	Up to 24 hours.

Google Analytics, permanent cookie, third-party cookie, performance cookie.	The cookie is used to anonymously distinguish visitors to the website and store information about how visitors use the website, i.e., where they come from, the number of visitors, which pages are visited. This allows us to analyze and improve the website and compile statistics.
